Please read the following before submitting your application.

- Block Party Application must be accompanied by a check payable to the “Township of Deptford” in the amount of \$25.00 which is refundable in the event that the permit is denied. Another check payable to the “Township of Deptford” is also required in the amount of \$50.00 which is a refundable deposit for township barricades.
- A Hold Harmless Agreement must be attached to the Block Party Application.
- A copy of the letter to all residents in the neighborhood providing notification of the planned event must also be attached to the Block Party Application.
- Block Party Application must have a petition signed by 75% of residents on the block and/or 75% of the residents of an apartment complex. All names and addresses must be included.
- Copy of Tax Map showing street location and surrounding cross streets to be temporarily barricaded must be attached to the Block Party Application.
- Applications will be returned if not complete and/or if not signed or if received later than twenty-one (21) days prior to the event.
- Permit will be valid not before 8:00 A.M. or after 11:00 P.M.

Barricades: Official Deptford Township barricades must be used to block-off the section of the street being used for the Block Party. These barricades are available by contacting our Public Works Department at (856) 228-4719 between the hours of 7:30 A.M. and 3:30 P.M. at least 72 hours prior to your event in order for them to be dropped off. Notification to our Public Works Department on the next business day to arrange for barricades to be picked up.

When approved, a Block Party Permit shall be issued authorizing the applicant to close the street. It is subject to revocation if the applicant does not comply with all pertinent laws, rules and regulations including any conditions or restrictions imposed by the Township of Deptford
